



#### 4. FIRST AID MEASURES

##### First aid measures

<b>Eye contact</b>	Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing eye. If eye irritation persists: Get medical advice/attention.
<b>Skin contact</b>	Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Wash contaminated clothing and shoes before reuse. Get medical attention if irritation develops and persists.
<b>Inhalation</b>	Remove to fresh air. Administer oxygen if breathing is difficult. Aspiration into lungs can produce severe lung damage. Call a physician immediately.
<b>Ingestion</b>	Do NOT induce vomiting. Do not give anything by mouth. If spontaneous vomiting is about to occur, place victim's head below knees. #### 5. FIRE-FIGHTING MEASURES

##### Suitable extinguishing media

##### Specific hazards arising from the chemical

This product can burn but will not readily ignite. This product will release vapors when heated above the flash point temperature and can ignite when exposed to a source of ignition. **Methods for containment** Prevent further leakage or spillage if safe to do so.
