#### 4. FIRST AID MEASURES

##### First aid measures

<b>Eye contact</b>	Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing eye. If eye irritation persists: Get medical advice/attention.
<b>Skin contact</b>	Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Wash contaminated clothing and shoes before reuse. Get medical attention if irritation develops and persists.

This product can burn but will not readily ignite. This product will release vapors when heated above the flash point temperature and can ignite when exposed to a source of ignition.
